## Shirin Ebady, First Iranian to Win a Nobel Prize

Shirin Ebady, the 2003 winner ing those who have fallen victim of the Nobel Peace Prize, will be the keynote speaker at the Fifth Biennial Conference of the International Society for Iranian Studies. Ms. Ebady is the first Iranian and the first Middle Eastern woman to win a Nobel prize. Only 10 women before her have won this prestigious award.

The Iranian lawyer and human rights activist was born in 1947 and received a law degree from University of Tehran. She served as president of the city court of Tehran and was the first female judge in Iran, a position she was forced to resign after the revolution in 1979. She now works as a lawyer and also teaches at the University of Tehran.

Ebady has displayed great personal courage as a lawyer defendto a powerful political and legal system. She has shown her willingness to cooperate with representatives of secular as well as religious views, and is recognized particularly for her tireless work to promote the rights of women, children and refugees. She is the founder and leader of the Association for Support of Children's Rights in Iran. The Executive Director of the UN Children's Fund (UNICEF), Carol Bellamy, stressed that Ebady's efforts had inspired "all of us who care about children... The recognition of Ms. Ebady by the Nobel committee is like a gift to children everywhere".

Kofi Annan, the Secretary General of the United Nations, also spoke highly of her and said that he hoped the award would underscore the importance of expanding human rights throughout the world and empower women to speak out and insist on their rights.

Ms. Ebady is known for promoting peaceful, democratic solutions to serious problems in society, and has been involved in a number of controversial political cases. She was the attorney for the families of the writers and in

## Bam <sub>'</sub>

The catastrophic earthquake in Bam on December 26, 2003, claimed more than 40,000 lives and left 1,700 children orphaned. Not only was the Citadel of Bam, one of the great historic monuments of Iran, devastated, but also many schools, libraries and cultural centers.

Initial response bringing help was quick. Iran accepted aid from all over the world, except Israel, which had offered to send a team of trained rescue dogs and supplies. The United States sent a group of doctors and a mobile hospital, which was left in Iran for further use. The continued on page 5



## The Roshan Cultural Heritage Institute

In the past, The International Society for Iranian Studies has benefitted from the generosity of a number of people and institutions in organizing its various activities. One such organization is The Roshan Cultural Heritage Institute.

This Institute, founded by philanthropist and linguist, Dr. Elahé Mir-Djalali Omidyar, in 2000, is a private, not-for-profit foundation dedicated to the active preservation and promotion of Persian cultural heritage, through partnerships with academic institutions, individuals and other not-for-profit organizations. The 4<sup>th</sup> Biennial Conference of Iranian Studies was partly supported by this Institute.

The Roshan Institute has already established named fellowships at UCLA, the University of Washington and the University of Arizona, as well as awarded individual grants and scholarships to exceptional students in Persian studies.

The Institute's work is focused on four major areas: 1) Funding Persian studies departments or programs at major U.S. universities; 2) Assisting existing U.S. not-for-profit organizations that share the Institute's vision/

mission; 3) Establishing the Roshan Institute Graduate Fellowship for Excellence in Persian Studies; and 4) Establishing a number of annual Roshan Institute Prizes for Outstanding Achievements by Iranians in the fields of science, humanities and the arts. "Love and Yearning: Mystic and Moral Themes in Persian Poetry and Painting" at the Smithsonian's Arthur M. Sackler Gallery in Washington, DC



(through February 22, 2004) is an exhibition funded by this Institute.

Dr. Mir-Djalali Omidyar, its founder, holds a Ph.D. in linguistics from the Sorbonne, Université de Paris, as well as two Masters degrees, one from the Sorbonne and the other from Georgetown University in Washington, DC. Her postdoctoral work has been in crosscultural research and in the fields of language teaching methodology and Persian Studies. She taught linguistics at UC Berkeley between 1992 and 2000. Her interest in Persian mystical poetry and prose has resulted in numerous translations from Persian into French and English.

# Unlimited Free Access to Encyclopædia Iranica Online Volumes I-XI plus Supplement and Out-of-Turn Entries from Letters A to Z

The new web-based electronic publication of *Encyclopædia Iranica* is now available *free of charge*. All articles from volumes I-VI can be downloaded and viewed in pdf format. Volumes VII-XI of the *Encyclopædia* can be downloaded and viewed in text format. A comprehensive search engine that will allow visitors to the site to search for articles by topic, keyword and author is now in place.

Iranica has now developed a **new online section** for supplemental and outof-turn entries from letters A to Z. They have already invited over 900 articles to be written by outstanding scholars in the field of their expertise irrespective of alphabetical order. Over 250 articles have been received, of which 150 have been placed on their website and are accessible for viewing or downloading. Others will follow.

#### Bam... cont'd

US lifted part of its sanctions temporarily to allow funds and other aid collected in the US to be delivered to the victims of the quake. A number of concerts and other fundraising events have been held around the world by Iranians to collect money for the victims of the Bam earthquake.

After the earthquake many Iranians rushed to help the people of this city. Among them were various members of the publishing community, including the Publishers and Booksellers Union, which collected over Rls. 300 million, plus funds to build two high schools and a clinic. The Paper and Cardboard [Sellers] Union also collected funds to buy provisions. The staff of one publishing house donated one to five days' salaries. Other organizations, such as the Isfahani Publishers Cooperative, Iran PEN Society and even the young members of the Society for Child and Young Adult Writers also had drives to collect funds or goods for the establishment of schools and libraries in Bam. The Science and Arts Foundation has also decided to contribute to this enormous task by addressing the short and medium-term needs of Bam's educational sector through the establishment of an IT center in Barn. There are currently 10,000 students attending the tent schools that have been erected among the ruins of the city. The plans for the reconstruction of this city have not been finalized yet.

resident. A Ph.D. or equivalent terminal degree is required. Studies involving more than one country and collaborative research programs involving international colleagues are strongly encouraged.

Eligible Countries of Research Focus: Afghanistan, Iran, Iraq, Jordan, Egypt and Saudi Arabia

Maximum Award: \$30,000

Eligible Expenses: Travel and associated expenses, stipends, honoraria, materials, meeting and conference expenses, and publication expenses. Limited equipment may also be authorized if needed to conduct research.

#### The Harvard Iranian Oral History Project

The Harvard Iranian Oral History Project, having commenced its activities twenty-two years ago, has now reached the final stage. At this juncture, two of the main challenges it faces are a) preservation of the memoirs over time, and b) making them easily accessible to researchers around the world.

Currently, the collection can be read and heard only by visiting Cambridge, Massachusetts and Oxford, England. Moreover, the quality of audio recordings will deteriorate over time, leading to a loss of this valuable historical primary source. The principal activity of the final phase is to address both of these concerns by digitizing nearly 800 hours of audio recording and 18,000 pages of transcript.

The digitized audio recordings and transcripts will be deposited in the Harvard University Library Digital Repository Service and will be made available on the Internet through Harvard Library. The pilot project is now available on the Harvard web site at:

## The Heritage of the High Caliphate: Dinars, Dirhams and Coppers of the Late Umayyad and Early 'Abbasid Periods, ca. 700-950 CE

The American Numismatic Society, Thursday and Friday, June 24-25, 2004

Late Umayyad and early 'Abbasid dinars, dirhams and coppers, which replaced previous Sasanian and Byzantine style coinages, were not only the first distinctly Muslim coins, but formed for many years a vast monetary system stretching from North Africa to Central Asia. Today, they constitute documents for the study of the period.

The conference invites papers treating any aspect of coins of the late Umayyad and early 'Abbasid periods as artifacts of civilization and culture. The conference will also feature a workshop in reading the Arabic legends on these coins and a roundtable for the discussion of issues of common interest, and of coins if anyone wishes to bring them along. Abstracts should be submitted by March 5, 2004, but time permitting, late submissions will be accommodated where possible.

## Constitutional Amendment to Article VI.5.a. and VI.5.b

#### **CURRENT LANGUAGE**

Article VI. Officers

5.a. ... The President begins his or her term one year after being elected President-Elect, and he or she takes office following the Annual Business Meeting.

#### AMENDMENT TO THIS ARTICLE

5.a. ... The President begins his or her term one year after being elected President-Elect, and he or she takes office for a two year term following the Annual General Meeting. If approved, the two year tenure for President of the Society will take effect after the Annual General Meeting in 2005.

#### CURRENT LANGUAGE

Article VI. Officers

5.b. ... The President-Elect serves for one year as the President-Elect, beginning after the Annual Business Meeting which follows his or her election.

#### AMENDMENT TO THIS ARTICLE

5.b. ... The President-Elect serves for two years as the President-Elect, beginning after the Annual General Meeting which follows his or her election. If approved, the two year tenure for President-Elect of the Society will take effect after the Annual General Meeting in 2005.

Justification: Currently, the President serves a single one-year term. Based on past experience, it has become clear that a two-year term of office would provide the opportunity for greater continuity, efficiency, and effectiveness in the formulation and implementation of policies and decisions in areas constitutionally identified as within the purview of the chief executive officer of the Society. Extending the single year term for the President-Elect is based on the same rationale and would, it is hoped, produce the same results. The term of office for the immediate Past-President is not specified in the current Constitution—the implication being that it would be one year. This officer and office is mentioned in Article V.2, whereby the incumbent is mentioned as an ex officio member of the Council. By logic of implication from the old language, which suggests the term of office of the immediate Past-President is one year, one would be implying that his tenure would also be extended to two years. There is also a word change from "Business Meeting" to "General Meeting" in accordance with a previously requested amendment on the appropriate name for this body.

The world of Iranian Studies has lost one of its pre-eminent scholars. Jerome W. Clinton, Professor Emeritus of Near Eastern Studies and Iranian Culture and Society at Princeton University, passed away on November 7, 2003, at the age of 66.

A native of San Jose, Calif., Clinton earned his A.B. from Stanford University, an M.A. in English and American literature from the University of Pennsylvania, and an M.A. and Ph.D in Persian and Arabic literature from the University of Michigan. He served in the Peace Corps in Iran from 1962 to 1964 and taught in schools in Tehran and Amman, Jordan, from 1964 to 1970. He then returned to the United States to teach at the University of

Minnesota. In 1972, he was named director of the Tehran Center of the American Institute of Iranian Studies. In 1974 Clinton joined the Princeton faculty as professor of Persian, where he taught for twenty-eight years until his retirement in 2002.

Clinton's professional interests spanned literary theory and criticism, translation and translation theory, and, in recent years, the esthetics of wordimage relations. His many articles on classical Persian literature remain landmark studies of individual works. Chief among these are several articles on Khaqani. Above all, he was a scholar and translator of the Persian epic, *The Shahnama* (Book of Kings). His translations of episodes from it have been a staple of university classrooms, and in 2002 his rendition of the episode of Esfandiyar, published under the title *In the Dragon's Claws*, won the Lois Roth Persian Translation Prize.

Impressive as Jerry's scholarship was, it tends to pale before his vast humanity, his profound loyalty to his friends, and his ever-present habit of "shekasteh nafsi" (the breaking of the self), which he had so well combined with American self-effacement.

He will be missed.

tellectuals who were victims of the serial murders in 1999-2000. She has worked actively—and successfully—to reveal the principals behind the attack on the students at University of Tehran in 1999 where several died. As a consequence of her work, Ebady has been imprisoned on numerous occasions and has spent time in solitary confinement.

She has written a number of academic books and articles focused on human rights. Among her books translated into English are *The Rights of the Child: A Study of Legal Aspects of Children's Rights in Iran* (Tehran, 1994), published with support from UNICEF, and *History and Documentation of Human Rights in Iran* (New York, 2000). She has argued for a new interpretation of Islamic law which is in harmony with vital human rights such as democracy, equality before the law, religious freedom and freedom of speech. Ebady also supports the rights of members of the Baha'i community.

She was initially praised by Iranian officials on winning the Nobel Peace prize *and* criticized for attending the ceremonies and interviews without the Islamic *hejab* and for shaking hands with men.

The Executive Committee of ISIS is honored to have Ms. Ebady as the keynote speaker at the ISIS conference on May 28th.

### Sasanika Late Antique Near East Project

One of the most remarkable empires of the first millennium CE was that of Sasanian Persia, which encompassed modern Iran, Iraq, Central Asia, the Near East and Egypt. This empire brought together an array of ethnicities and religious practices. The relatively tolerant system of the Sasanians created a vibrant communal life among its Zoroastrian, Jewish, and Christian citizens, and was a model for the Ottoman *millet* system.

It is the aim of the Sasanika: Late Antique Near East Project to highlight the importance of Sasanian civilization. The project, headed by Touraj Daryaee and a board of prominent scholars, has several aims. 1) Integration of the Sasanian Empire into the fields of late antiquity and world history by exchanging information with the journal, Antiquité tardivelLate Antiquity, The Society for Late Antiquity (http://www.sc.edu/ltantsoc/), and encouraging involvement in the biennial conferences. 2) The creation of a website dedicated to Sasanian civilization (sasani.net). 3) The establishment of panels on Sasanian studies at conferences. 4) Publication of Sasanian material culture. The California State University, Fullerton has an agreement with the National Museum of Iran to publish its Sasanian seals in the future and with the Museum of Money in Tehran to publish its Sasanian coins and seals.

## Encyclopædia Iranica

FASCICLES 1 AND 2 OF VOLUME XII PUBLISHED; FASCICLE 3 IN PRESS

The first and second fascicles of Volume XII of the Encyclopædia Iranica were published in the Summer and Fall of 2003, continuing with the letter H. They feature over 120 articles including an extended series on Sadeq Hedayat, Hazara groups in Afghanistan, Helmand River and Herat.

These fascicles feature 16 entries on Afghanistan. Hazara ethnic groups are the subject of four articles: Historical Geography, History, Ethnography, Social Organization, and Hazaragi Dialect. Helmand River, on the border of Iran and Afghanistan, is treated in four articles: Geography, in Zoroastrian Tradition, in Medieval Period, in Latter Part of the 19th Century and in the 20th Century. Occupying an important place in medieval as well as modern history, the city of Herat is the subject of seven articles: Geography, Pre-Islamic History, Medieval

History, Medieval Urbanism and Topography, Local Histories of Herat, The Herat Question and Herat Frontier in the latter half of the 19th and the 20th Centuries.

Pre-Islamic History and culture is the subject of 23 entries: seven entries treat Iran's history from Medieval to Modern times; three articles treat aspects of Social Relations in premodern times (Hasab o Nasab, Haydari and Nemati, and Harem); and ten articles are devoted to Persian statesmen and other figures of the Pahlavi Period.

Shi'ism and Isma'ilism are treated in twelve entries. Four discuss the History of Medicine in Persia and three entries deal with the History of Astronomy and Mathematics, while Persian Music is treated in four entries, including History of Harp in Persia from ancient times. Also published in these fascicles are nine articles on other subjects.
