#### 1983 ANNUAL MEETING OF THE SOCIETY

The Society's Eighteenth Annual Meeting was held (in conjunction with the annual meeting of the Middle East Studies Association) in Chicago from November 3-6. The University of Chicago acted as host.

As in the past, the SIS Council held its meeting on the first day of the conference from 1:00-3:00 p.m. and the Annual Business Meeting was held from 3:00-5:00 p.m. on the same day. A summary of reports presented by officers of SIS and decisions made at the two meetings is given below:

#### Executive Secretary's Report - Habib Ladjevardi (presented at the Annual Meeting)

1. Computerization of Society Records - All available SIS files & records were transferred to Cambridge in December 1982. Additional records in possession of Gene Garthwaite will be received in the near future. The Executive Secretary then stated that it is only when a newcomer tries to carry on the work of his predecessors that he appreciates the extent of time and effort that they have dedicated to the task. And it was with this in mind that he wished to say that the Society owed a great deal to Lois Beck, the previous Executive Secretary, & Ervand Abrahamian and Farhad Kazemi who had kept track of subscription billings and records in the past.

Beginning in December 1982 the new Membership and Subscription Manager, Laura Serafin, and the Executive Secretary have attempted to carry on the work, by centralizing the membership and subscription records—using an Apple Computer at Harvard's Center for Middle Eastern Studies. Payment information, address changes, new members and subscribers are easily incorporated into the record. As a result the Society has been able to keep better track of unpaid subscriptions and membership dues.

- 3. Membership List The Executive Secretary reported that preparation of an SIS directory of members including their addresses is being contemplated. Also we have received inquiries regarding the possibility of selling our membership list. After a discussion of the various aspects of this issue, it was decided that because some members may not wish to publicize their mailing addresses, no list which would include the members' addresses should be issued at the present time. However, list of members with their organizational affiliation may be published. Also if a qualified organization wishes to send a mailing to SIS members, the Society may undertake to do the mailing directly for an appropriate fee.
- 4. <u>Newsletter</u> The Executive Secretary said that he would like to expand items of news regarding new courses, research, etc. being carried out on Iran by the members. To do this, the active cooperation of everyone is needed.
- 5. Plans for Next Year As for next year, the Executive Secretary stated that he hoped to launch a drive to increase the number of members and subscribers. To accomplish this task, a special brochure is being prepared and a publicity campaign begun. Also an effort will be made to increase advertising in the Journal.

Finally, the Executive Secretary proposed that steps be taken to launch a campaign to raise funds for an endowment fund. All donations will be placed in a special deposit account. All or part of the income will be used to expand the Society's activities and to reduce its dependence on annual income. The portion of income to be used for the Society's expenses shall be determined at the next meeting of the Council. The Council accepted this proposal with enthusiasm. All members agreed to take an active role in the campaign. Marvin Zonis was asked and accepted to be chairman of this effort. The tax deductability of gifts should be stressed. Perhaps all members should be approached to consider giving a special gift of at least \$50.00 to the Endowment Fund.

6. Proposal to Amend the Constitution - The Executive Secretary stated that as a prelude to the drive to increase the number of members and subscribers, it is important to differentiate between voting members and non-voting members and subscribers. At the present time there is no distinction between these groups as anyone who subscribes to the <u>Journal</u> is automatically considered a voting member. The proposal, as presented, was based on categories and definitions adopted by MESA. After discussion and some revisions, the Council approved the amendments and asked the Executive Secretary to send it to the members for their vote.

#### Treasurer's Report - John H. Lorentz

I am happy to report that the present financial condition of the Society is the best in its history. Not yet fully sound, the Society is no longer operating from hand to mouth and is clearly moving in the right direction. To illustrate, in the four previous fiscal years the Society only managed to generate a surplus of \$470.47 of receipts over expenditures. In the first 9 months of 1983 the surplus stands at \$4,572.47. Taking into account anticipated income and expenditures for the remainder of 1983, I expect that amount to dip, but a still-healthy surplus to remain.

Even more encouraging with regard to financial solvency is the pattern of income for 1983. In the past several years, grant funds for restricted or special projects have kept the Society barely in the black. Without these nearly \$10,000 of earmarked funds, it would have been impossible to maintain the stepped-up publication schedule of the past several years and not go into the red. However, these funds were both restricted and one-shot affairs. Furthermore, even with them we could not accumulate a surplus. The difference in 1983 is a substantial increase in receipts in the two most important categories of continuing support -- regular members and institutonal subscriptions. It is on these primary bases of support that the Society will accumulate a modest surplus for 1983 and move into 1984 in a reasonably sound financial position.

#### The Editors' Report - Ervand Abrahamian and Farhad Kazemi

The editors' tasks and operations have in the past year become increasingly more routinized and rationalized. Close cooperation between the editors and the executive secretary has made the Journal's operation more professional. The Apple computer at the disposal of the executive secretary has effectively freed the editors to handle the more immediate problems of manuscript review and publication decision. As in the past, manuscripts submitted for publication are generally evaluated by two outside reviewers in addition to the editors. In most cases, we have been able to reduce the waiting period before a decision is reached to about 90 days.

In 1983, Volume 16 (nos.1-2) was published and distributed to the members. Volume 16 (nos.3-4) is currently in press. The editors are also proud to have issued the <u>Cumulative Index of Iranian Studies</u> for Volumes 1-15. Computer facilities and other institutional assistance were provided by New York University for preparation of the Index. Jo-Anne Hart served as the compiler and editor of the Index. We are grateful for her able assistance in this difficult and tedious task. All members of the Society will receive the Index as part of their membership privileges.

The editors are currently negotiating the possibility of cosponsorship of special issues of <u>Iranian Studies</u> with several institutions including Columbia University and the American Institute of Iranian Studies. If these negotiations prove fruitful, then important portions of the Journal's production expenses will be borne by the cosponsoring organizations. It is our sentiment that such joint ventures are useful both financially and as a means of engendering cooperation among institutions with similar goals.

Dr. Vahid Nowshirvani, Columbia University, joined the editorial board of the Journal in 1983. As you all know, Dr. Nowshirvani is an economist who served as the Journal's associate editor in 1976-81.

The editors received the advice and counsel of many colleagues in the past year. We are specially thankful to the following: Shahrough Akhavi, Ahmad Ashraf, Shaul Bakhash, Ali Banuazizi, Jerome Clinton, William L. Hanaway, Jr., Habib Ladjevardi, Laura Serafin, Naomi Schorr, Ehsan Yarshater, and Marvin Zonis.
